She shall further note that if any Backward Class candidates or surplus teacher is made available by the Social Welfare / Education Directorate etc. for absorption, vide Government G.R. No. UGC-1293 / (2647) / Vishi-4, Dt. 27<sup>th</sup> May 1997 & Government Circular No. NGC-AS / Shikshak / 1097 / MV-3, she will have to leave her services immediately & will not be entitled to any notice or notice pay in lieu of notice.

In case she accepts the appointment, she shall have to submit discharge certificate from her present employer, if any, and to execute a deed of contract of service.

Her appointment is on probation for 2 years and is subject to available actual workload for 2000-2002. The appointment is subject to the approval of University/ Government authorities. She shall note that no salary as per actual workload is due till post and appointment is approved by University / Government & pay shall be payable only after specific approval and salary grants are received for the same. No complaint will be entertained to that effect. She shall note that her services are transferable in Gokhale Education Society's Colleges.

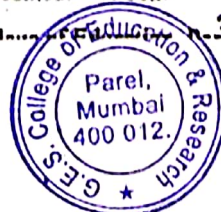
